The aim is to ensure local governance and sustainable management of SEPLS of the Ramsar site 1018 so that present generations can derive maximum sustainable benefits while retaining its capacity to meet the needs and aspirations of future generations.

The activities developed are environmental education of local communities, including editing and dissemination of sustainable management rules for the protection of wetland ecosystems and African manatee; and training of eco-guardians, including a mangrove planting action; and support for the development of alternative income-

generating activities.

The results have led to better organization of local communities and better protection of biodiversity and wetland ecosystems (SEPLS), as well as direct benefits for community livelihoods.

Lessons learned from the project suggest that improving the knowledge of indigenous and local communities and building their capacity is a better way to reassure them of their responsibility and increase their influence in monitoring and conservation of SEPLS.

The success of the conservation of SEPLS is a contribution to the implementation of national and global biodiversity strategies and action plans, to the improvement of traditional knowledge for the sustainable use of biodiversity; and the eradication of extreme poverty.
