<p>Initiated the institutionalization of enhanced empowerment for women to apply nurturing through maternal ecohealth in the context of the SEPLS designs and using the indicators of resilience toolkit as guide; established a biocultural heritage maternal reserve in marine and inland ancestral domain waters</p>

<p>The complexity of Philippine culture, resource harvest and governance are traditional barriers to effective Coastal Resource Management (CRM). The project demonstrated that advanced innovations in CRM could enter an institutionalization process when focused on the engagement and empowerment of women.</p>

<p>The inclusive engagement of marginalized sectors at various levels, including those that are impoverished and have limited roles due to gender can result in cultural shifts towards sustainability and improved health.</p>
