The beneficiary communities are peasant farmers whose livelihood is centered along the Weto Landscape of Akwapim Togo Mountain Range. Biodiversity of the range is threatened due to unhealthy farming practices contributing to the loss of ecosystem services and land degradation with its associated poor crop yields

Description of human-nature interactions in the area

As peasant farmers, their activities are centered on utilization of natural resources along the mountain range with limited interest in the low-lying grassland. They believe in conservation and so created Indigenous Community Conserved Areas (ICCAs) but with the growth in population, modernization and foreign religions, these sites are threatened and getting extinct

Major threats to biodiversity conservation are unhealthy farming practices and field fires. The project therefore seek to restore the biodiversity which was lost due to excessive removal of vegetation on the mountain range, by decreasing wild fire risks and promoting organic rice cultivation.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

1, To restore and conserve ecosystem services in Tafi and Ve portions / areas of the Weto Mountain Landscape through the introduction of environmental education and wildfire prevention measures.

2, To enhance the living standards of women and youth through organic rice production and value chain development. 3,To develop Civil Society Organization (CSO) and community engagement handbook on Biodiversity conservation

Activities and/or practices employed (within 50 words)

There was community entry to introduce project to stakeholders for their buy-in. Community fora were organized towards removal of wildfire risks and capacity enhancement of firefighting volunteers. Beneficiary communities were sensitized on organic agriculture, value addition, conservation and resource mobilization. Project management committee was formed for the project sustainability.

Results (within 50 words)

The project covered 1,610 hectares of land under organic rice farming with over 598 beneficiaries including women with enhanced standard of living. Two resourced fire volunteers trained and supporting removal of wild fires in project communities. Two effective project management teams in place for sustainability after protect exit.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

While mobilizing communities for organic agriculture, government was distributing subsidized synthetic agrochemicals within project communities. With consistent education, production value addition and distribution of organic product will enhance the living standards of the people
