This coalition linking with scientists' has managed to do biodiversity conservation and utilization jointly.

Naxi people's popular saying, "Human and Nature are brothers", bio-culture perspective with community based nature resource management with their religion belief and spiritual values had been losing, and have gradually restored and revitalized by themselves with linkages and support from other stakeholders in the last decade.
