Socioeconomic and environmental characteristics of the area (within 50 words)

The area around the project site consist mainly of poor fishermen communities relying mostly on lagoon fishing for their daily subsistence. The project site is unique as it has freshwater coming down the river from one side where it joins the ocean making it very rich in marine biodiversity.

Description of human-nature interactions in the area

(land-use, traditional resource management practices etc. – within 50 words)

The area of Macondee is dominated mostly by vulnerable poor fishermen communities. They rely solely on the lagoon resources for their subsistence. Most of these fishermen are old and uneducated and has been using only traditional fishing methods for the last decade.

Rationale (why activities or policies described, or information shared in the case study are needed – within 50 words)

SELPS are poorly understood and managed in Mauritius. This project demonstrated that an abandoned estuary which was also a SEPLS could be transformed into mariculture site for mud crabs which encouraged the fishermen to stop fishing from an already over stressed lagoon with depleting resources.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

The overall objective of the project was to increase the knowledge of SELPS among the fishermen communities of Macondee village in Mauritius and at the same time transform an abandoned estuary into a mariculture site for mud crab culture as a demonstration project.

Activities and/or practices employed (within 50 words)

The activities were to introduce the fishermen to SEPLS concept, enhance the project site by cleaning the site, train the fishermen on mud crab culture and finally build a floating mud crab structure as a demonstration project where they can rear their own mud crabs.

Results (within 50 words)

A floating mud crab structure was built and placed at the project site. Around 50 fishermen and their families could directly benefit from the project. The whole community of Macondee benefited indirectly from this project. This action has also increased awareness of SELPS among the fishermen communities to stop fishing in the lagoon.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

The main lesson learned from this project was to really listen to the fishermen community especially when the floating structure was built so that the specification is correct for mud crab rearing.

Key messages (within 40 words)

Always start a project from the bottom-up approach and work with the community following to their request. Then take those requests and develop it into a project. Once this is done, the satisfaction of the fishermen community is extraordinary.
