The project was implemented in an indigenous community where the inhabitants mostly live based on agriculture and fishing with an average monthly income of 100.00 USD.

The region is an important site for ecology and forest, where 75% of the territory is used for conservation in a natural way and under customary rules of the Guna people's.

Description of human-nature interactions in the area

The population of the Usdub community is directly dependent on forest resources, biodiversity and its ecosystems to meet their basic needs such as food, water, natural medicine, spirituality and cultural practices.
