Because of the small amount of honey production, stingless bee is considered less economical. However, it is important for plant pollination. Stingless bees mainly distributed in the Alishan aboriginal tribes. Due to environmental changes and the large number of chemical drugs used, the stingless bees gradually disappeared.

Stingless bees in Taiwan is a native endemic species. Its honey and propolis is the traditional use for aboriginal. If this project succeeds, it will be of great help to the farmers.

Stingless bee lives in the forest which abundant with balsam and the presence of it indicates the biodiversity. It is suitable for greenhouse pollination and the efficiency is obviously. Both pollination and propolis product development are really worthy and all these efforts are meaningful for environmental protection and economic improvement.

We create the stingless bee field in Ilan city and the number of stingless bee increase. We also defined their plant source and bee plant. Since lots of typhoons and earthquakes, Greenhouse cultivation is popular and important in Taiwan. Stingless bees flying distance about hundreds meters and is suitable for greenhouse pollination. In this project succeeds, it did great help to the farmers.
Lessons learned <i>(factors in success or failure, challenges and opportunities – within 40 words)</i>
Artificial swarm need to make suitable beehive, beehive shape, material and place to be tested. In addition, there are many natural enemies, including ants, spiders, geckos, stewed cattle, slugs, swallows, cut leaves, must be in the absence of medication to find the right way to control. At present, our beehive all use physical method for deworming.
Key messages <i>(within 40 words)</i>
We succeeded in clarifying Taiwan's plant sources and bee plants of stingless bees, and making bee food suitable for improving strength and reproduction. The problem of artificial breeding and reproduction of breeding was solved. It also preliminarily completed the pre-pollination trial of greenhouse bitter melon. These results have attracted attention of other relevant units in Taiwan.
