The Philippines is among the most vulnerable to disasters triggered by natural hazards and flooding. Population growth and urbanization of low-lying areas will further increase flood risk and endanger communities. Communities need to prepare for more severe and frequent river and urban flooding in the future due to climate change.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

The objective of the case study is integrating nature-based solutions (NbS) investment options into the Flood Risk Management (FRM) Master Plans for the river basins. This includes developing methodologies to blend <u>Natural River Management (NRM) approach</u> into FRM. The case study serves as models for replication and upscaling for practitioners.

Activities and/or practices employed (within 50 words)

The NRM stepwise approach is useful in quickly assessing NbS interventions. This practice sets comprehensive and multiple objectives and the conduct of a multicriteria analysis. The steps also help stakeholders understand the river dynamics, socioeconomic context, and institutional system in the whole river system, including the upstream and downstream areas.

Monitoring methodology (e.g. GIS-based monitoring, citizen science, Resilience Indicators in SEPLS, survey - within 40 words)

ADB applies the <u>Design Monitoring Framework</u> in its operations to track results and impacts which are aligned with ADB's results framework that contains indicators measuring outputs and outcomes as well as contribution to the <u>Sustainable Development Goals</u>. This case study contributes to SDG13 on climate change and SDG9 on resilient infrastructure.

Results (within 50 words)

Applying NRM resulted to several investment NbS options for the FRM of the river basins which include mangrove and wetland conservation and restoration, creating green river connections, accommodating natural river meandering, and erosion protection using vegetation. These should be in combination with "grey" infrastructure such as construction of drainage systems.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

Each river basin presents unique challenges and opportunities which require a holistic perspective such as natural river management. Mixing green ecosystem-based approaches also provide opportunities to enhance sustainability and expected benefits but requires community engagement to weigh tradeoff different measures.

Funding sources for the case study include the Infrastructure Preparation and Innovation Facility (\$300.00 million), Technical Assistance Special Fund (\$1.00 million), Cooperation Fund for Project Preparation in the Greater Mekong Subregion and in Other Specific Asian Countries (\$300,000.00), and the Technical Assistance Special Fund and Climate Change Fund (approximately \$412,782.10).
