In the 1990s, City of Chengdu saw rapid urban expansion, leading to significant loss of arable land, the rise of shantytowns, poor industrial development, and environmental degradation. These changes increased urbanrural inequalities. In 2023, an ecological zone was planned and delineated on the city's outskirts to curb urban growth and improve socio-ecological conditions.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

The goals of Chengdu's ecological zone (CDEZ) include reducing urban-rural income disparities, providing economic opportunities and public services, improving rural infrastructure, and increasing land use efficiency. Its planning prioritizes ecological conservation, local history, multifunctional development, and maximizing public access, aiming to create a balanced urban-rural connection where nature and settlements co-evolve.

Activities and/or practices employed (within 50 words)

Key actions for Chengdu's Ecological Zone (CDEZ) included adopting the Comprehensive Plan (2012), implementing regulations to control land use and protect open space, investing in infrastructure like lakes and wetlands, and promoting agritourism and recreation. Government programs ensured that development aligned with a landscape-focused approach to achieving socioecological goals.

Monitoring methodology (e.g. GIS-based monitoring, citizen science, Resilience Indicators in SEPLS, survey - within 40 words)

Chengdu's monitoring methodology for the Ecological Zone (CDEZ) integrates an indicator system with GIS to track land use and assess environmental impacts. Over 100 land markers have been erected since 2012 to demarcate boundaries, ensuring public monitoring. Interviews reveal a growing emphasis on transparency and public involvement in the process.

Results (within 50 words)

By 2020, Chengdu's Ecological Zone (CDEZ) featured lakes, rivers, forests, and wetlands, complemented by a 300-km greenway system connecting parks, cultural sites, rural communities, and agritourism businesses. Public transit provides easy access, enhancing connectivity. Continuous improvements are being made, with monitoring supporting ongoing adjustments to the zone's development.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

Strategies ensuing success are those aligned with the UN Habitat Urban-Rural linkage principles, including locally grounded approaches that prioritize human rights and social protection, systems-based governance using functional and spatial integration, environmentally sensitive strategies informed by data and evidence, inclusive and equitable investment, participatory engagement, and partnerships fostering balanced development across urban and rural areas. Challenges also existed, including the need for continuous substantial financial investment and institutional capacity to maintain and manage the CDEZ.

Funding (any relevant information about funding of activities or projects described in the case study)

Funds from multiple government levels—national, provincial, and local—have supported the development of Chengdu's Ecological Zone (CDEZ). These financial contributions have been crucial in implementing infrastructure, regulations, and environmental protections, ensuring the success and ongoing development of the zone. New funding strategies are experimented, including revenue obtained from increase in land value for sites adjacent to the CDEZ, land lease income, spatial re-arrangement of development sites within the zone that can bring additional economic return.
