The sheer number of visitors come either go on the jeep/bus rides, or visit the souvenir shop, the elephant camp or stay overnight in the lodges, or have a stopover at the Tribal Community Restaurant for breakfast and lunch is a clear indication that, good SPVs if created with a process orientation, will succeed, and ensure for themselves.
