At the end of World War II, the Battle of Okinawa was fought between Allied and Japanese forces on the Okinawa islands. This was a ground war directly involving the people of the prefecture. All four sites presented in this case study were directly affected by the war, although the ways in which they interacted with nature differed.

Description of human-nature interactions in the area (land-use, traditional resource management practices etc. – within 50 words)

All four sites presented in this case study show the different ways in which people and nature interact. However, attempts to create a new relationship between nature and people, having recovered from the devastation of the war, also show us directions that we have not seen before.

All four sites presented in this case study were affected by the Battle of Okinawa and the subsequent occupation but attempts are being made to create a new relationship between nature and people although interactions differ depending on the purpose of each site.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

The AEON Environmental Foundation is involved in creating a new relationship between the natural environment and human beings in order to lay the foundation for peace. Here four support activities are introduced to present the support from AEON.

Activities and/or practices employed (within 50 words)

Four activities are introduced; tree planting at the Peace Memorial Park; tree planting at the former final waste disposal site in Naha; prevention of red soil runoff that destroys the sea; and forest conservation by the "Home of the Okinawa rail" in Yanbaru.

Results (within 50 words)

Trees are grown well at the Peace Memorial Park and the former final waste disposal site. Network for prevention of red soil runoff is extended thanks to support from AEON. Forest conservation initiated by local people, including the "Home of the Okinawa rail" is institutionalized at the national and international level.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

A new nature-people relationship has been developed at all four sites thanks primarily to local initiatives and wider collaboration among concerned stakeholders. AEON's support was well utilized by such initiatives and collaboration.

The creation of a new relationship between nature and people in Okinawa is inseparable from the pursuit of peace, and is steadily ushering in a new era.
