White water snowflake was a wild vegetable in today's Meinong District when Hakka farmers settled it in the mid-1700s. Jacanas used them for breeding. Later, land use changes resulted in both disappearing. In 1975, local cultivation of the plant began. Expanding the planting area in 2000 led to jacanas returning.
