It is a brackish area and suitable for mangrove. Their socio-economic condition is not up to the mark.

A Guideline on Sundarbans Mangrove SATOYAMA Conservation is developed. Regular coordination meeting among the organizations took place for reduce the gap. 100 fishermen families income is increased through promoting traditionally dried packaged shrimp. Fishermen families' biodiversity knowledge is increased through Sundarbans biodiversity conservation education program.

The lesson we learned from the project is how to engage poor communities with conservation activities and how to promote local technology for poverty reduction. We also learned about how to reduce the gap of coordination between organizations. We also learned to develop a Co-Management strategic action plan.

An Action Plan for conserving Sundarbans is developed and it is the most significant achievement of the project. Local communities' spontaneous participation in project activities is another achievement of the project.
