Aboriginal tribes in Taiwan's east coast are located between Central Mountains and Coast Mountains. Tribal environment in Hualein are clean and mostly isolated. Agricultural fields in tribes are located near asayama forests and heat-water point. Because of this unique positions, they possess diverse but fragile ecology.

The tribes play the important roles of connecting human activities and primitive natural environment. Agricultural fields are located near forest or primitive environment. And those environment are close to homes of wildlife. Based on the specialty of local agricultural products, our investigation were done in rice paddies in Ceroh tribe, Yuli and in pomelo orchards in Olalip tribe, Ruisu, Hualien.

Aboriginal tribes in Taiwan's east coast are located between Central Mountains and Coast Mountains. They play the important roles of connecting human activities and primitive natural environment, which symbolize the satoyama spirit.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

We notice and consider the important connection between aboriginal farming and agro-ecosystem. By the combination of aboriginal plants and ecofriendly farming, we hope to strength the ecosystem in tribes. Our ultimate objective is the solution to promote agriculture activities meanwhile maintain sustainable ecosystem in tribes.

Activities and/or practices employed (within 50 words)

- 1. In order to collect the background information in rice paddies and pomelo orchards, we did the investigation of insects' species between different farming methods.
- 2. For figure out the suitable habitat, we preliminary screened aboriginal plants, and we did the lifespan assay of beneficial insects on them.

Monitoring methodology (e.g. GIS-based monitoring, citizen science, Resilience Indicators in SEPLS, survey - within 40 words)

- 1. Investigation by sweeping net and beat netting.
- 2. Cultivation of aboriginal plants.
- 3. Scientific methods of insects breeding.

Results (within 50 words)

The population of total insects were higher in organic paddies than conventional ones, especially spiders and beneficial insects. The stable existence of beneficial natural enemies' population may have great effect on pests' regulation.

The results showed that there were 7 plants, especially *Indigofera spicata*, *Vitex trifolia* and *Anster indicus* could extend the lifespan of *Dirhinus giffardii*.

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

Some aboriginal plants could extend the lifespan of beneficial insects. If these plants grow and stably exist in fields, they can provide alternate shelter for parasitoid wasps. In addition, make contribution on pests' regulation.
