Rationale (why activities or policies described, or information shared in the case study are needed – within 50 words)

TPSI was established in 2015 as a network of satoyama-minded partners working on revitalisation of Taiwan's SEPL(S). Prior to introduction of the Project, despite existing experiences related to biodiversity conservation, sustainable production and local livelihoods, there was a gap in a comprehensive understanding of socioecological resilience in TPSI SEPL(S). The Project was aimed to address this gap.

Objectives (goals of activities or policies described, or of producing the case study – within 50 words)

The Project was carried out through January-December 2021 based on the following objectives: 1) develop locally-sensitive indicators of resilience reflective of characteristic features of eight TPSI SEPL(S) mentored by eight district offices of the Forestry Bureau (DOFB), 2) conduct community-based RAWs in eight TPSI SEPLS in order to (a) assess their socio-ecological resilience, (b) identify environmental and socio-economic risks and resources, and (c) elicit the most urgent issues and future management interventions.

Activities and/or practices employed (within 50 words)

Training of trainers workshops, localisation of indicators of resilience and implementation of community-based RAWs in eight TPSI SEPL(S) with the assistance from eight DOFB and four TPSI regional exchange bases, joint workshop on discussion of RAWs results, development and publication of relevant knowledge and capacity-building materials (articles, guidebooks, video-recordings)

Results (within 50 words)

The Project (1) demonstrated the first ever development of thematically comprehensive, locally relevant and easily comprehensible localised indicators of resilience for Taiwan's SEPL(S) and a systematic and synchronous implementation of RAWs at a national scale across the network of a government agency; (2) enhanced collaboration across TPSI network, strengthened the mentorship role of TPSI regional exchange bases and stimulated peer-to-peer learning; (3) proved the suitability of RAWs as a monitoring and evaluation tool within the Taiwan Ecological Network (2022-2025).

Lessons learned (factors in success or failure, challenges and opportunities – within 40 words)

Factors in success: support and interest from all Project stakeholders, pro-active facilitation efforts of the NDHU Team, flexible adjustments throughout the implementation of the Project, openness to iterative learning and knowledge co-production;

Challenges: COVID-19 and related restrictions on in-person activities, Project's time constraints for more indepth local engagement;

Opportunities: integration of RAWs results into adaptive landscape-(seascape) management in SEPL(S), future RAWs in other areas on a SEPL(S)-to- SEPL(S) learning basis.

Key messages (within 40 words)

The Project not only demonstrated the suitability of RAWs for a nationwide assessment of resilience in SEPL(S), but also opened new opportunities for a long-term in-depth engagement with the local communities and sustainable management in SEPL(S).
